Do not send payment with application. This is a juried event. Sending in an application doesn't guarantee acceptance. The Show Committee reserves the right to accept or reject any application. Once accepted & signed by FWGMC vendor chair, an email confirmation and contract will be sent. Completed contracts with 50% downpayment must be returned by **July 1st** with the remainder payment received by **Aug 1st, 2025**.

This is a kid-friendly event. Do not present any offensive materials. Tables are priced per 8ft table with a minimum of 4 tables. Space allocations are designed by the vendor chair based on the number of dealers accepted for the show. Dealer space is the area contained within the allocated limits of the contracted tables. Dealer furnished tables/shelves/extensions used to display merchandise will be charged as a table. A table may be set up only within the contracted space for non-merchandise. Dealer displays shall not extend into aisles or adjoining areas and must not interfere with other vendors. **Cost is \$95 per table with a minimum of 4 tables.**

The Dealer shall:

- Vendor will cover table to within 4" of the floor (required) with fire resistant covering in accordance with City of Fort Worth Fire Code regulations.
- People, companies or organizations wishing to demonstrate only may be given space, if available. Non-profit organizations will be allowed (space available) to sell or take orders provided their merchandise does not compete with dealers.
- No wholesale dealers.
- No MLM products.
- No guns, knives, political, or offensive items.
- Factually and honestly, represent all merchandise for sale.
- Keep space clean and neat. Take precautions to protect the floor if necessary.
- Secure all licenses and pay State and City sales taxes.
- All merchandise presented for sale shall pertain to rocks, gems, minerals, fossils, geology, lapidary, metalsmithing, jewelry, and/or related earth sciences. There are some exceptions; the Show Chairperson will make the final decision.

The Show Chairperson reserves the right to change the location or space allocations to provide a proper layout and for the good of the show.

Vendor agrees to hold FWGMC & its members harmless from any loss, claim, loss of action, liabilities, expense, whether known or unknown to any person, persons, entity, or organizations arising out of the activities conducted on the premises.

Please provide photographs. Include photos of overall booth setup from a distance showing tables & detailed photos showing types of displays with merchandise.

** Electricity and internet are not included. It is optional & purchased through the venue.
